




PACKAGE DIMENSIONS








SPATIAL DISTRIBUTION








Forward Current Derating Curve

REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS



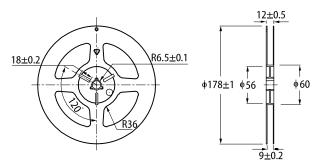

REEL DIMENSION (units : mm)


